#### IN RE: GARRARD COUNTY SHERIFF

Leanna Miller was in attendance. She needed the annual budget signed. She also presented the court with a check for 2024 excess fees in the amount of \$7,668.74. A motion was made to accept the check by Magistrate Barker and seconded by Magistrate Davis. All in favor.

# IN RE: DISTRICT 3 CONSTABLE

On December 31, 2024, the Garrard County Constable of District 3, John Dixon, resigned from his position. The Judge/Executive can appoint someone to fill the position or leave it vacant until the next election in 2026. Donnie Stephens is interested in filling the vacancy. There are limitations on how much

a Constable is allowed to do in the county without having adequate training. Judge/Executive Elleman and Sheriff Skeens will meet with Mr. Stephens to discuss it further.

#### IN RE: NOISE ORDINANCE VARIANCE REQUEST

Sunset Marina has requested a noise variance during the lake season for 2025. This variance will extend the current noise ordinance from 11:00 p.m. to 12:00 a.m. on weekends. Judge/Executive Elleman requests that the court grant this noise variance for all lake marinas in Garrard County during the lake season for 2025. A motion was made to approve by Magistrate Davis and seconded by Magistrate Barker. All in favor.

#### IN RE: LANCASTER PARKS/REC REQUEST

Chris Penix with Lancaster Parks and Recreation submitted a quote from Anthem Sports, LLC in the amount of \$12,028.92 for Kwik soccer goals. A motion was made to approve the purchase by Magistrate Davis and seconded by Magistrate Preston. All in favor.

#### IN RE: ROAD DEPARTMENT

Trevor Creech has completed all classes and paperwork for his Class A CDL License at his own expense. He is requesting that the Court pay for the expense of renting a truck and trailer from Ryder so that he can take the driving portion of the test on February 18, 2025. A motion was made to allow by Magistrate Barker and seconded by Magistrate Day. All in favor.

## IN RE: EMS EQUIPMENT

Rebecca Sizemore has presented a quote from Zoll Medical Corporation in the amount of \$82,866.75 for three X Series Monitor/Defibrillators. These monitors are required by KBEMS and check heart rhythm, oxygen saturation, etc. The EMS currently has three monitors, but they're all about ten years old and need to be replaced. The quote covers three monitors, which will be spread out evenly over the next three years, or one monitor replaced per year. The used equipment will be traded in toward the purchase price. The court plans to purchase the monitors from the LGEA Fund. A motion was made to approve by Magistrate Butner and seconded by Magistrate Preston. All in favor.

## IN RE: 2025 / 2026 JAIL BUDGET

The 6/30/2026 jail budget was presented. The total budget will decrease from \$550,000 down to \$538,500. The main decrease is in the Contracts W/ Other Counties line, while adding lines for vehicle insurance and workman's compensation insurance. A motion was made to approve the budget by Magistrate Day and seconded by Magistrate Barker. All in favor.
