### IN RE: LOGAN HUBBLE PARK

Garrard County received \$20,000 in the prior fiscal year from Atmos Energy for an easement. The county has purchased a side-by-side to use at Logan Hubble Park and would like to put some fencing around the playground area at the park. A quote was presented from Days Farm & Fencing in the amount of \$6,306.29 for a chain link fence. A motion was made to approve by Magistrate Barker and seconded by Magistrate Preston. Magistrate Day refrained from voting. All other Magistrates were in favor.

### IN RE: EMS EQUIPMENT

Rebecca Sizemore was in attendance. The new ambulance is in service but did not include a self-loading stretcher. She presented 2 quotes: one from Stryker in the amount of \$31,672.62 for a 6507 Power Pro 2, High Config and the second is from Bound Tree in the amount of \$18,750.00 for a Stryker Power Pro XT Model 6506 (Power Load & XPS Wings Not Included). The biggest difference is that one is lighter and has a light on it. Mrs. Sizemore thought the lower quoted Bound Tree would be sufficient. A motion was made to approve the \$18,750.00 quote by Magistrate Day and seconded by Magistrate Barker. All in favor.

## IN RE: EOC STORAGE BUILDING

Wanda Shelton submitted a request to CSEPP to update the EOC garage from two doors to three. A quote was presented from Lindsey's Garage Doors in the amount of \$8,500.00 to do the project. CSEPP will reimburse the county for this project. A motion was made to approve by Magistrate Davis and seconded by Magistrate Butner. All in favor.

### IN RE: MOUNT HEBRON ROAD (COUNTY)

Magistrate Barker said that he has looked at the roadway with Crawford Asphalt. They have submitted a quote in the amount of \$18,978.00 to repave sunk spots with 3 in base asphalt, spray tack coat and resurface 860 ft 2 in surface. A motion was made to move forward with Crawford Asphalt by Magistrate Preston and seconded by Magistrate Day.
