The meeting was called to order by Judge/Executive Chris Elleman.

Opening prayer by Daryl Hodge.

Opening Pledge of Allegiance led by Willie Skeens.

**MAGISTRATES PRESENT:** Glendan Barker, Bobby Preston, Wayne Day, Chris Butner and Chris Davis.

**IN RE: PUBLIC COMMENTS**

Mike Powers, a Tanyard Branch resident, was in attendance. He was asking for an update on the issue they presented at the November 10, 2025, meeting regarding the Benny Swope property. Judge/Executive Elleman said he has spoken to Freddie Green regarding his easement, but the court will not be involved in that civil matter.

Jerry Ensor was also in attendance. He said the haul trucks are bypassing the section of Tanyard Branch Rd between Hawk's Nest and Whitney Ln and the road is starting to crack. He was concerned about the project. Judge/Executive Elleman said no construction can be done without court approval. Mr. Ensor is concerned with the trucks driving through the yards on the turns on Whitney Ln.

Judge/Executive Elleman said he would meet with Mr. Powers tomorrow morning to map out the path that the trucks are travelling on. Mr. Powers also mentioned that he thought work should be done fairly on each half of the road from the middle line.

#### **IN RE: CHAMBER OF COMMERCE**

#### **IN RE: KCJEA (JUDGE ASSOCIATION) COMMUNITY OUTREACH PROGRAM**

At the November 24, 2025, meeting, Judge/Executive Elleman said that the KCJEA will be implementing a new program consisting of \$1,000 donations back to all 120 counties over a 4-year period. This year Garrard County was chosen. He has decided to award The Garrard County Community Food Bank and The Garrard County Ministerial Association with donations of \$500.00 each. Both organizations are located in Garrard County as non-profit organizations and are registered as 501(c)(3). Checks should be received at the February Judge's Conference.

#### **IN RE: CCBIP AGREEMENT (OLD RAILROAD GRADE ROAD BRIDGE REPLACEMENT)**

The Kentucky Transportation Cabinet has prepared an Agreement whereby the Cabinet will provide up to \$503,839.00 in reimbursable state funds to Garrard County to repair/replace Bridge No. 040C00009N on Old Railroad Grade Road (CR 1104). The County will pass a resolution authorizing the Judge Executive to sign this Agreement on behalf of the County. A motion was made to enter into the Agreement by Magistrate Day and seconded by Magistrate Davis. All in favor.

## **IN RE: CCBIP RESOLUTION (OLD RAILROAD GRADE BRIDGE REPLACEMENT)**

A Resolution was presented adopting and approving the execution of a Memorandum of Agreement between the Garrard County Fiscal Court and the Commonwealth of Kentucky, Transportation Cabinet, Department of Highways in the amount of \$503,839.00 for the Old Railroad Grade Road Bridge No. 040C00009N (CR 1104). The Judge/Executive of the County is hereby authorized and directed to sign said Agreement as set forth on behalf of the Fiscal Court of Garrard County. A motion was made to allow signing by Magistrate Davis and seconded by Magistrate Butner. All in favor.

## **IN RE: COUNTY CLERK**

Clerk Kevin Montgomery was in attendance.

- **2026 CLERK BUDGET**  
Delinquent taxes have been increased for calendar year 2026, as well as Chattel Mortgages. Total anticipated receipts are \$5,973,115 and anticipated expenditures are \$5,762,607. This leaves excess fees in the amount of \$210,508. A motion was made to approve the budget by Magistrate Davis and seconded by Magistrate Day. All in favor.
- **2026 MAXIMUM SALARIES**  
Pursuant to KRS 64.530(3), "The fiscal court shall fix annually the maximum amount, including fringe benefits, which the officer may expend for deputies and assistants...". The fiscal court of Garrard County in compliance with state law hereby sets the maximum amount which the Clerk of Garrard County may expend from fees during calendar year 2026 at \$300,000.00 for deputies, assistants and other employees. The maximum amount as set includes all amounts paid from fees for: full time salaries and wages and health insurance. A motion was made to approve by Magistrate Davis and seconded by Magistrate Butner. All in favor.
- **2026 CLERK BONDS**  
The Clerk carries a \$100,000 bond with Public Entity Insurance that is effective in September. A motion was made to approve by Magistrate Day and seconded by Magistrate Davis. All in favor.
